Re: Affiliation

As a result of the NOHA going to electronic registration beginning with the 2010-2011 season, the following “Frequently asked Questions” and attached information indicates the changes to how the NOHA will deal with affiliation and what is required by Associations and Teams in order for a player to participate as an Affiliated Player.

Attached are the following forms:

- 1- NOHA Regulation Number Seven – Affiliation
- 2- NOHA Affiliation Declaration
- 3- NOHA Affiliation at Large List (if applicable)
- 4- NOHA Affiliation Chart – who can you affiliate with?
- 5- NOHA Player Affiliation Record

If you have any questions in regards to Affiliation, please contact your District Council Director or the NOHA Office.

Frequently asked questions

- 1- When must I declare my Affiliation for the season?

You must declare and have your affiliation approved by the NOHA Executive Director by October 15th or before you are allowed to use any affiliate player(s).

- 2- When does the Game Official have to review and sign the NOHA Player Affiliation document?

Every time you use an affiliated player you must present all the required documents as listed in NOHA Regulation Seven.

- 3- The Regulation states five (5) games in Minor Hockey after January 10th. Do I have to get the NOHA Player Affiliation Record signed by the game Official before this date?

As stated in question number 2 - Every time you use an affiliated player you must present all the required documents as listed in NOHA Regulation Seven.

4- I use an Affiliation at Large List. When do I need to file my list of players?

As per NOHA Regulation Seven you must have the player approved by the NOHA before you use the player. The final date to add a player to this list is January 15th.

5- Can a player participate as an affiliated player in the game if I do not have the proper documents?

As per NOHA Regulation 7.4 - Teams must have a NOHA Player Affiliation Record form duly completed for each player(s) participating in any game as an affiliated player. The NOHA Player Affiliation Record form must be signed by the Referee for each game this player participates. Teams must also have a copy of the Teams approved Affiliation Declaration.
