The NOHA is pleased to announce that it will host the inaugural NOHA Officials School at Nipissing University in North Bay on August 12-14, 2011. Participating Officials will have a tremendous opportunity to learn from very knowledgeable Officiating instructors during the three day event.

In addition to re-certification for the 2011-2012 season, the school has been designed to provide all NOHA Officials with further opportunity to learn and improve as an Official through in-class and on-ice training sessions.

Agenda

Registration for the school is scheduled to begin at 4:00 p.m. on Friday, August 12 at Nipissing University and the event will conclude at approximately 11:00 a.m. on Sunday, August 14. All activities, including meals, will be held at Nipissing University, aside from the ice sessions. A complete agenda will be available shortly after the registration deadline.

Tentative topics for the Program include: Referee & Linesman Procedures, Rules Assignments, Communication, Game Management, Harassment and Abuse, Supervision and an OHL Presentation.

In addition, the school will include two ice sessions for all Officials – Power Skating and Procedures.

Registration Fee

The registration fee for the NOHA Referee School is \$400.00 + HST (\$452.00) for Officials who require accommodations, and \$330.00 + HST (\$372.90) for Officials who do not require a room.

The above-noted registration fee includes the following:

- Accommodations for two nights (if required) at Nipissing University's Residences; accommodations will be four people per complex (four rooms in an apartment-style complex)
- Meals provided beginning Friday evening through to breakfast on Sunday morning
- NOHA Officials Registration fee for the 2011/2012 season
- In-depth instruction from the top Officiating instructors from Northern Ontario who have backgrounds in the NHL, OHL and NOJHL
- Two on-ice sessions, including a Power Skating session
- Opportunity to be upgraded (Level 2-1 up to Level 2, Level 2 up to Level 3-1) based on passing of the Hockey Canada Officiating Exam

Officials are responsible for their own travel, but are encouraged to carpool with others where possible.
